- 3.Electronic Bidding Document is available online and can be downloaded on or before 12:00 PM on 16th day from the date of publication. Documents received after this deadline shall not be accepted on 16th day from the date of publication.
- 4.The Bidder shall be required to deposit the non-refundable fee of NRs. 1,000 in the Internal Revenue account as specified below and electronic scanned copy (pdf format) of the Bank deposit voucher shall also be submitted along with the electronic bid files.

- 5.Bidder Shall submit the electronic bid through website http://www.bolpatra.gov.np/egp on or before 12:00 PM on or before 16th day from the date of publication as specified in the Instructions to Bidders. Bids received by the above mentioned deadline shall be opened electronically in the presence of Bidders' representatives who choose to attend at the address above at 1:30 PM on 16th day from the date of publication.
- 6..In the case of discrepancies or error in bid documents, bid notice or any other documents, Sanibheri Rural Municipality reserves the right to amend and correct at any time. The figure for the bid amount must be clear if any discrepancy may occur then the figure written in word is valid.
- 7.Bids must be valid for a period of **45 days** counting from the day of bid opening and must be accompanied by bid security amounting as stated above deposited at **(Dharauti account No. 0770530787703004) on behalf** ofofSanibheri Rural Municipality, *Rukum (West)* at Sunrise Bank Limited, Sanibheri Branch, Rukum (West) or bid bond authorized from a recognized commercial bank of Nepal, which shall be *valid for minimum 30 days* beyond the bid validity period.
- 8.If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 9.Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
