- The Bidder shall be required to deposit the non-refundable fee of NRs. 3,000 in the Internal Revenue Account as specified below and electronic scanned copy (pdf format) of the Bank deposit voucher shall also be submitted along with the electronic bid files.

Bids received by the above-mentioned deadline shall be opened electronically in the presence of Bidders' representatives who choose to attend at the address above at 01:00 PM on 31st day from the date of publication.
- In the case of discrepancies or error in bid documents, bid notice or any other documents, Sanibheri Rural Municipality reserves the right to amend and correct at any time. The figure for the bid amount must be clear. If any discrepancy may occur, then the figure written in word is valid.
- Bids must be valid for a period of 120 days counting from the day of bid opening and must be accompanied by bid security amounting as stated above deposited at (Dharauti Account No. 0770530787703004) on behalf of Sanibheri Rural Municipality, Rukum (West) at Sunrise Bank Limited, Sanibheri Branch, Rukum (West) or bid bond authorized from a recognized commercial bank of Nepal, which shall be valid for minimum 30 days beyond the bid validity period.
- If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
- Sanibheri rural Municipality reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
- All other conditions of the bidding process will be as per the Public Procurement Act, 2063 and Public Procurement Regulation, 2064.
