4. The bidder shall be required to deposit the non-refundable fee of NRs 1,000 in the internal revenue account as specified below and electronic scanned copy (pdf format) of the bank deposit voucher shall also be submitted along with the Electronic Bids file.

Bids received by the above mentioned deadline shall be opened electronically in the presence of bidder representatives who choose to attend at the address above at 1:00 PM on Oct-27, 2022 from the date of publication.

6. In the case of discrepancies or error in bid documents bid notice or any other documents, Sanibheri Rural Municipality reserves the right to amend and correct at any time. The figure written in word is valid.

7. Bids must be valid for a period of 45 days counting from the day of bid opening and must be accompanied by bid security amounting as stated above deposited at (Dharauti Account No .0770530787703004) on behalf of Sanibheri Rural Municipality Rukum (West) at Sunrise Bank Limited Sanibheri Branch Rukum (West) or bid bond authorized from a recognized commercial bank of Nepal which shall be valid for minimum 30 days beyond the bid validity period.

8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case, the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
