- Bids must be valid for a period of 120 days counting from the day of bid opening and must be accompanied by bid security amounting as stated above deposited at (Dharauti account No. 0770530787703004) on behalf of of Sanibheri Rural Municipality, Rukum (West) at Sunrise Bank Limited, Sanibheri Branch, Rukum (West) or bid bond authorized from a recognized commercial bank of Nepal, which shall be valid for minimum 30 days beyond the bid validity period.
